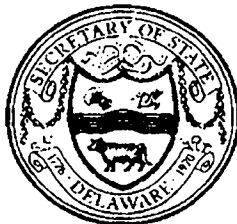

**CERTIFICATE OF AMENDMENT
TO
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
SEARLES VALLEY MINERALS OPERATIONS INC.**

Matthew J. Dowd certifies that he is the Secretary of Searles Valley Minerals Operations Inc., a Delaware corporation (the "*Corporation*") and that the Amended and Restated Certificate of Incorporation of the Corporation is hereby amended in accordance with Section 242 of the General Corporation Law of the State of Delaware (the "*DGCL*") and adopted by the Directors of the Corporation and the sole stockholder to read as follows in full:

FIRST: That the Certificate of Incorporation of the Corporation be, and hereby is, amended by deleting Article I in its entirety and substituting in lieu thereof a new Article I to read as follows:

"The name of the Corporation is Searles Valley Minerals Inc. (the *Company*)."

SECOND: That at a regular meeting of the Board of Directors held on January 9, 2012, a quorum of Directors being present and participating in the meeting, the Directors present and participating by a unanimous vote adopted and approved the foregoing amendment and directed that such amendment be submitted to the stockholders of the Corporation entitled to vote thereon for their consideration, approval and adoption thereof.

THIRD: That the stockholders entitled to vote thereon approved the foregoing amendment by the written consent of its majority in accordance with Sections 228 and 242 of the DGCL.

FOURTH: That this name change shall be effective as of 9:00 A.M., Eastern Daylight Time, on 2 April 2012.

IN WITNESS WHEREOF, the undersigned does hereby certify under penalties of perjury that this Certificate of Amendment to the Amended and Restated Certificate of Incorporation of the Corporation is the act and deed of the undersigned and the facts stated herein are true as of the 28th day of March, 2012.
