RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT

THIS RELEASE of the Patent and Trademark Security Agreement ("Release of IP Security") is executed as of 28 August, 2012, by J.P. Morgan Europe Limited, as security agent for the Secured Parties (the "Security Agent"), for the benefit of FLA. Orthopedics, Inc. and American Orthopedic Supports, Inc.(collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the meaning assigned to such terms in the IP Security Agreement (as defined below).

WHEREAS, pursuant to the Patent and Trademark Security Agreement, dated as of November 21, 2007 (the "IP Security Agreement"), between the Grantors and the Security Agent, which IP Security Agreement was recorded in the U.S. Patent and Trademark Office (the "Office") on December 3, 2007, at Reel 020186/Frame 0129, and on December 3, 2007, at Reel 003670/Frame 0541, the Grantors have granted a security interest in its right, title and interest in and to the Patent and Trademark Collateral (as defined therein), including without limitation the intellectual property listed on Schedule A and B attached hereto to the Security Agent; and

WHEREAS, in connection with the discharge of all liabilities and obligations, the Secured Parties have agreed to release the security interests created under the IP Security Agreement on the terms and conditions set forth in that certain Global Deed of Release, dated as of 28 August, 2012, between, inter alios, the Security Agent and the Grantors.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereby unconditionally and expressly releases, terminates and extinguishes any and all of its right, title and interest in the Patent and Trademark Collateral granted to the Security Agent for the benefit of the Secured Parties pursuant to the IP Security Agreement, including, without limitation, any and all of its right, title and interest in the intellectual property listed on Schedule A and B attached hereto, and relinquishes onto the Grantors all such right, title and interest, as of the date first written above.

This Release of IP Security shall be limited precisely as written and relates and applies solely to the Patent and Trademark Collateral, including without limitation the intellectual property listed on Schedule A and B attached hereto and the associated interests specifically described above.
