TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS, dated as of 11 September 2012 is made pursuant to the Intellectual Property Security Agreement dated as of March 10, 2009 (the "Security Agreement") by and among Thule Organization Solutions, Inc. (the "Obligor") and Nordea Bank AB (PUBL), as Collateral Agent (the "Collateral Agent") for the Lenders referenced in the Security Agreement.

WHEREAS, the Obligor, Thule Organization Solutions, Inc., granted a security interest in certain intellectual property to the Lenders, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks");
