
AFFIDAVIT

I, Philip M. Impink, am the President of Giorgifred, a corporation organized in the state of Delaware and owner of the U.S. Registrations attached in Schedule A, and hereby state:

- (1) GIORGIFRED COMPANY is incorrectly identified as an Investment Company rather than a Delaware Corporation in the U.S. Patent & Trademark Office records for the registrations listed on Schedule A;
- (2) The registrations listed on Schedule A were transferred by Nunc Pro Tunc assignment from GIORGIO FOODS, INC. ("Assignor") to GIORGIFRED COMPANY ("Assignee") on September 15, 1989;
- (3) The Nunc Pro Tunc assignment document that was signed by Assignor and recorded with the Assignment Branch of the U.S. Patent & Trademark Office at Reel/Frame 0789/0346, identified Assignee by the correct name of GIORGIFRED COMPANY but contained a clerical error that erroneously identified Assignee as an Investment Company rather than a Corporation. It is believed this is the result of a scrivener error;
- (4) The correct entity type of Assignee is, and always has been, a Delaware Corporation; and
- (5) Correction of the Assignee's entity type in the assignment records of the U.S. Patent & Trademark Office is hereby requested to correct GIORGIFRED COMPANY from an Investment Company to a Delaware Corporation.

The undersigned, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, declares under penalty of perjury that the information in this Declaration is true and correct to the best of his knowledge, information and belief.

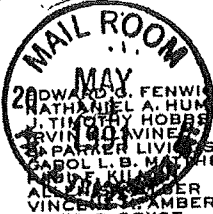


