CORRECTIVE ASSIGNMENT

THIS AGREEMENT is effective as of December 31, 2010.

WHEREAS, LIVENOTE, INC., a company incorporated in the State of Delaware, with offices at 610 Opperman Drive, Eagan, Minnesota USA ("LiveNote"), adopted, acquired, and used exclusively in its business in the United States the trademarks on Schedule A attached hereto (the "Marks");

WHEREAS, on December 31, 2010, LiveNote entered into an agreement with Thomson Reuters Global Resources, an Irish unlimited company with offices located at Neuhofstrasse 1, 6340 Baar, Switzerland ("TRGR") pursuant to which LiveNote agreed to sell certain non-US trademark rights to TRGR (the "Intellectual Property Assignment Agreement");

WHEREAS, LiveNote inadvertently included the Marks on the Schedule to the Intellectual Property Assignment Agreement;

WHEREAS, on May 12, 2011, LiveNote executed a confirmatory assignment agreement for the purpose of recording the assignment of the Marks to TRGR with the U.S. Patent and Trademark Office (the "USPTO") (the "Confirmatory Agreement") and recorded the Confirmatory Agreement with the USPTO at Reel 004539/Frame 0555;

WHEREAS, LiveNote and TRGR acknowledge and agree that TRGR is not and never was the beneficial owner of the Marks, and the parties wish to correct the ownership records of the Marks to remove the incorrect assignment of the Mark to TRGR from the chain-of-title.

NOW, THEREFORE, TRGR and LiveNote agree that

- (i) The Intellectual Property Assignment Agreement shall be amended to remove references to the Marks from the Schedule;

(ii) The Confirmatory Agreement was prepared in error and is hereby deemed null and void;


and

(iii) LiveNote shall file a corrective assignment with USPTO to remove the assignment of the Marks to TRGR from the Mark's chain-of-title.
