**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of September 17, 2012, is made by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH** (f/k/a Credit Suisse, Cayman Islands Branch), as agent (the “**Collateral Agent**”), under the Amended and Restated Second Lien Guarantee and Collateral Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Amended and Restated Second Lien Guarantee and Collateral Agreement).

WHEREAS, under the terms of (i) that certain Amended and Restated Second Lien Guarantee and Collateral Agreement, dated as of March 19, 2008, (as amended from time to time, the “**Amended and Restated Second Lien Guarantee and Collateral Agreement**”), among Cydcor, Inc., a Delaware corporation (“**Cydcor**”), 20/20 Communications, Inc., a Delaware corporation (“**20/20**”; and together with Cydcor, the “**Borrowers**”), Cydcor Acquisition Holdings Corporation, a Delaware corporation (“**Holdings**”), and certain subsidiaries of the Borrowers party thereto from time to time, whether as an original signatory thereto or as an Additional Grantor (together with Holdings and the Borrowers, each, a “**Grantor**,” and collectively, the “**Grantors**”), and Credit Suisse AG, Cayman Island Branch (f/k/a Credit Suisse, Cayman Islands Branch), as collateral agent for the Secured Parties and (ii) those certain agreements described on Annex I attached hereto (collectively, the “**Security Agreements**”), the Grantors granted security interests in certain intellectual property including those listed on Annex I attached hereto (collectively, the “**Intellectual Property Collateral**”); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto;


NOW THEREFORE, the Collateral Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or the Amended and Restated Second Lien Guarantee and Collateral Agreement, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Intellectual Property Collateral to the Grantors.


This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
