Grant of Security Interest in United States Trademarks

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Catalyst Paper Corporation, a corporation duly organized and existing under the laws of Canada (the "Grantor"), hereby grants Canadian Imperial Bank of Commerce, as Administrative Agent, (the "Grantee"), a security interest in all of Grantor's right, title and interest in, to and under the following:

THIS GRANT is granted in conjunction with the security interests granted to the Grantee pursuant to the Security Agreement among the Grantor, the Grantee and certain other parties thereto, dated as of September 13, 2012, as amended, restated, modified or supplemented from time to time (the "Security Agreement"), and is expressly subject to the terms and conditions thereof. The rights and remedies of the Grantee with respect to the security interest granted herein are more fully set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
