## RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **September 4, 2012** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain **Collateral Assignment (Intellectual Property)**, dated as of **April 22, 2010** and recorded **April 22, 2010 Reel 004190 Page 0903** in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Twincor Romax LLC**, (the "Debtor") and the Secured Party;


