**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of September 20, 2012 by BANK OF AMERICA, N.A. ("**Secured Party**").

WITNESSETH:

- (b) All Goodwill associated with such Trademarks; and
- (c) All proceeds of any and all of the foregoing.

2. Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Secured Party, all of Secured Party's right, title and interest in and to the Trademarks.
