TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of September 20, 2012 by BANK OF AMERICA, N.A., a National Association, a national banking association, as administrative agent (“**Agent**”).

WITNESSETH:

WHEREAS, Agent and VEIN CLINICS OF AMERICA, INC., a Delaware corporation (“**Grantor**”), were parties to that certain Amended and Restated Trademark Security Agreement dated as of May 21, 2010 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the “**Trademarks**”) and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule I hereto; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under the Trademarks and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):

- (a) All Trademarks of the Grantor listed on Schedule I attached hereto;
- (b) All Goodwill associated with such Trademarks; and
- (c) All proceeds of any and all of the foregoing.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks.
