**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of September 20, 2012 by BANK OF AMERICA, N.A., a National Association, a national banking association, as administrative agent (“**Agent**”).

W I T N E S S E T H:

WHEREAS, Agent and INTEGRATED AMERICA, INC., a Delaware corporation (“**Grantor**”), were parties to that certain Amended and Restated Trademark Security Agreement dated as of May 21, 2010 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the “**Trademarks**”) and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademark set forth on Schedule I hereto; and

- (b) All Goodwill associated with such Trademarks; and
- (c) All proceeds of any and all of the foregoing.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks.
