Supplemental Nunc Pro Tunc Trademark Assignment and Agreement

This Supplemental Nunc Pro Tunc Trademark Assignment and Agreement (the "Assignment and Agreement") is between U.S. Natural Resources, Inc. ("USNR"), a Delaware corporation, and Friedrich Air Conditioning Co., Ltd. ("Friedrich"), a Texas limited partnership.

Whereas, USNR is the sole limited partner of Friedrich;

Whereas, prior to July 31, 2012, USNR was the owner of certain trademarks and trademark applications described on Schedule A attached hereto;

Whereas, pursuant to two Nunc Pro Tunc Trademark Assignments, dated July 31, 2012, and August 2, 2012 (the "Previous Assignments"), USNR and Friedrich sought to confirm in writing the assignment from USNR to Friedrich of all right, title, and interest in and to such trademarks, which assignments were duly recorded in the United States Patent and Trademark Office at Reel 4835, Frame 0616 (July 31, 2012 Assignment) and Reel 4837, Frame 0312 (August 2, 2012 Assignment), respectively; and

Whereas, out of an abundance of caution, USNR and Friedrich wish to execute this Supplemental Nunc Pro Tunc Trademark Assignment to confirm, evidence and effectuate the intent of the Previous Assignments;


Now, WHEREFORE, for good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge:

To the extent that any of the rights described below have not already been assigned, conveyed, and transferred to Friedrich, USNR hereby assigns to Friedrich, the entire right, title and interest in and to the trademarks and trademark applications described on Schedule A attached hereto, and all foreign counterparts thereto, together with any and all common law and other rights that USNR has, had, or may ever have corresponding to any such trademarks, in all countries throughout the world, together with all of the goodwill associated therewith, including the right to sue for and recover for past infringement.

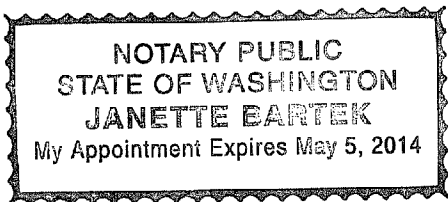

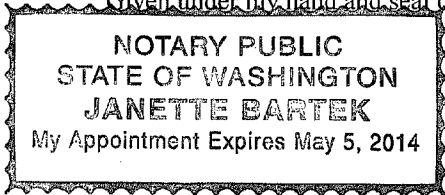
