## Release of Lien on Trademarks

WHEREAS, pursuant to an agreement which was recorded with the United States Patent and Trademark Office (the "USPTO") at Reel/Frame Number 3699/0875, the grantors thereof ("the Grantors") granted to Bank of America, N.A., as collateral agent (the "Collateral Agent") a lien on and security interest in and to all of its right, title and interest in, to and under all trademarks and trademark applications listed on Schedule A hereto;

SECTION 1. *Release of Security Interest in Trademark Collateral.* Such Collateral Agent hereby releases and terminates its lien on and security interest in and to all of its right, title and interest in, to and under all trademarks and trademark applications set forth on Schedule A hereto and in each case reassigns to the Grantors all right, title and interest in and to such trademarks and trademark applications.


