NOTICE OF CHANGE OF ADMINISTRATIVE AGENT

WHEREAS, LodgeNet Interactive Corporation (formerly LodgeNet Entertainment Corporation), a Delaware corporation ("LodgeNet") or its subsidiaries (together with LodgeNet, the "Grantors"), owns all right, title and interest in and to the trademarks and trademark applications listed in Schedule A hereto (the "Trademarks");

WHEREAS, pursuant to the Credit Agreement dated as of April 4, 2007, (as amended by the First Amendment, dated as of March 17, 2011 (the "Amendment"), and as further amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among LodgeNet, the several lenders from time to time parties thereto (the "Lenders"), the Syndication Agent and Documentation Agent party thereto and JPMorgan Chase Bank, N.A. (as the successor agent to Bear Stearns Corporate Lending Inc.) as Administrative Agent for the Lenders (together with successors and assigns in such capacity, the "Administrative Agent"), the Secured Parties severally agreed to extend credit to the LodgeNet upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Grantors executed and delivered a Guarantee and Collateral Agreement, dated as of April 4, 2007, in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Collateral Agreement");

WHEREAS, pursuant to the Collateral Agreement, the Grantors pledged and granted to the Administrative Agent a security interest in all Intellectual Property, including the Trademarks, on terms and conditions set out in the Collateral Agreement;

WHEREAS, the security interest in the Trademarks granted to the Administrative Agent was recorded by means of the Trademark Security Agreement with the Trademark Division of the United States Patent and Trademark Office at Reel 3514 Frame 0647 on April 4, 2007;

WHEREAS, the Administrative Agent wishes to update the U.S. Patent and Trademark Office records to accurately reflect that it is the current Administrative Agent for the above Collateral Agreement, which includes the security interest granted by the Grantors in the trademarks and trademark applications listed on Schedule A hereto;

NOW, THEREFORE, the Administrative Agent hereby states and confirms as follows:


1. Bear Stearns Corporate Lending Inc. has ceased to be the Administrative Agent for the Lenders under the Credit Agreement, the Collateral Agreement and the other Loan Documents;

2. JPMorgan Chase Bank, N.A. is now the Collateral Agent for the Lenders under the Credit Agreement, the Collateral Agreement and other Loan Documents; and
3. JPMorgan Chase Bank, N.A., is the authorized representative of Bear Stearns Corporate Lending Inc.

All other terms and conditions are more fully set out in the Credit Agreement and the Amendment, which are hereby incorporated by reference. Unless otherwise defined herein or the context otherwise requires, the terms used in this agreement shall have the meanings provided or provided by reference in the Credit Agreement, the Amendment, the Collateral Agreement or other Loan Documents.


