Assignor represents and warrants to Assignee that: (a) Assignor has not sold, assigned or transferred the Trademarks or any applications or registrations relating thereto to any other party; and (b) Assignor has all rights and authority to enter into this Trademark Assignment.

This Trademark Assignment shall inure to the benefit of and be binding on the successors and assigns of each of the parties hereto.


