## ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS ("Assignment of Trademarks") made and entered into effective July 12, 2012, by and between Ronald E. Stadtmueller ("Assignor" or "Trustee"), as the Trustee of the chapter 7 bankruptcy estate (the "Estate") of Ahmad and Terri Lyn Stiles Alkayali (collectively the "Debtors"), and **QUALITY RAW MATERIALS & PREMIXES, L.L.C.**, a limited liability company organized and existing under and by virtue of the laws of the state of California and having its principal place of business at 1000 S. Melrose Street, Suite B, Anaheim, California 92870 (hereinafter "Assignee").

### RECITALS

WHEREAS, the Debtors filed a voluntary petition under title 11, United States Code (the "Bankruptcy Code") on June 30, 2011 (the "Petition Date") and Debtor's bankruptcy case is currently pending as Case No. 11-11082-LT7 before the United States Bankruptcy Court for the Southern District of California (the "Court");

WHEREAS, as of the Petition Date, Debtors owned or claimed an interest in the following trademarks, along with, to the full extent owned by the Trustee and/or within his authority to convey, the underlying goodwill of whatever business or arrangement may use such marks (collectively the "Assets"):

WHEREAS, the Court has held that, pursuant to the provisions of section 541(a) of the Bankruptcy Code, the Assets are the property of the Estate;

WHEREAS, the Assignor desires to convey, transfer, assign, deliver and contribute to Assignee all of the Estate's right, title, and interest in and to the Assets, whether known or unknown to the Trustee, in "as is" and "where is" condition without any claim or warranty of validity, enforceability or factual support associated with either; and Assignee desires to receive the Assets under said conditions;

WHEREAS, on or about June 27, 2012, the Court entered an order (the "Sale Order") that approved the Trustee's sale of the Assets to Assignee and consistent therewith the parties entered into an asset purchase agreement (the "Asset Purchase Agreement") dated July 12, 2012, and no order of the Court, or any applicable appellate court has been entered prohibiting or

otherwise staying the effect of the Sale Order, the Trustee's execution of this Assignment or the transfer of the Estate's right, title and interest in the Assets to the Assignee;

NOW, THEREFORE, in consideration of payment of the purchase price set forth in the Asset Purchase Agreement and other good and valuable consideration, and the mutual covenants contained herein and in the Asset Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby conveys, transfers assigns, delivers and contributes to Assignee all of the Estate's right, title, and interest of whatever kind in and to the Assets. Without limiting the extent of the Assets as defined in the recitals set forth above, the Assets include the following:

All of Assignor's worldwide right, title and interest in the registrations and unregistered common law rights associated with the trademarks along with, to the full extent owned by the Trustee and/or within his authority to convey, the underlying goodwill of whatever business or arrangement may use such marks listed below:



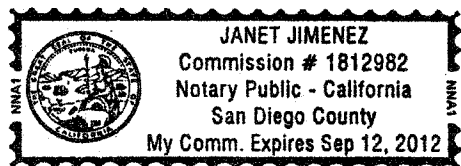


