## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is effective as of May 24, 2012, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association (f/k/a Wachovia Bank, National Association) ("Wells Fargo").

### WITNESSETH:

WHEREAS, Wells Fargo and Advanced Duplication Services, LLC, a Delaware limited liability company ("ADS"), are parties to that certain Trademark Security Agreement dated as of July 17, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Wells Security Agreement"), pursuant to which ADS granted a security interest to Wells Fargo, among other things, the trademarks (and intellectual property relating to same) set forth on Exhibit A hereto; and

WHEREAS, the Wells Security Agreement, was recorded in the Assignment Services Division of the United States Patent and Trademark Office on July 17, 2008, at Reel 003818, Frame 0341; and

WHEREAS, ADS has requested that Wells Fargo release its security interest in the trademark collateral subject to the Wells Security Agreement and release the security interest granted pursuant to the Wells Security Agreement;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Wells Fargo hereby releases its security interest in all of ADS's right, title and interest in and to all of the trademark collateral, including without limitation the security interest granted by the Wells Security Agreement, the trademark registrations referred to in Exhibit A annexed hereto and the goodwill of ADS's business connected with the use of and symbolized by the trademark collateral.
2. Subject to other security interests granted by ADS to other financial institutions, Wells Fargo hereby reassigns, grants and conveys to ADS, without any representation, warranty, recourse or undertaking by Wells Fargo, all of Wells Fargo's right, title and interest in and to the trademark collateral, including without limitation the trademark registrations referred to in Exhibit A annexed hereto and the goodwill of ADS's business connected with the use of and symbolized by the trademark collateral.



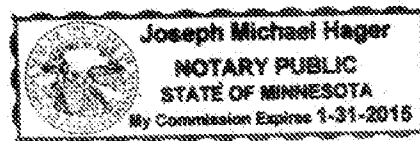
