U.S. TRADEMARK ASSIGNMENT

THIS U.S. TRADEMARK ASSIGNMENT (this "Assignment") is entered into as of September 25, 2012, by and between Paramount Citrus Packing Company LLC, a Delaware limited liability company ("Paramount") and Sun Pacific Shippers, L.P., a California limited partnership ("SP", and together with Paramount, collectively "Assignors"), on the one hand, and Maricopa Packers, L.P., a California limited partnership with a principal place of business of 11444 West Olympic Blvd., 10th Floor, Los Angeles, California 90064, USA ("Assignee"), on the other hand.

WHEREAS, Assignors were parties to an arbitration proceeding which, in part, involved the Marks (as defined in paragraph 1 below), entitled *In the Matter of the Arbitration between Sun Pacific Group, Claimant and Paramount Group, Respondent and Counterclaimant*, Case Number 72-180-Y-01187-11, which took place before the American Arbitration Association Commercial Arbitration Tribunal;

WHEREAS, the American Arbitration Association Commercial Arbitration Tribunal issued a Partial Final Award Order on September 7, 2012 ordering the transfer of the Marks from Assignors to Assignee (the "Order"); and

WHEREAS, the parties desire to effectuate the terms of the Order in a writing that can be filed with the United States Patent and Trademark Office;

NOW THEREFORE, in consideration of the foregoing, the Assignors hereby assign and transfer to Assignee:

1. All right, title and interest held by Assignors in and to the business names, trade names, trademarks and/or service marks, and the applications and/or registrations therefor, and all common law rights thereto, listed in Exhibit "A" attached hereto and incorporated by this reference (hereinafter collectively referred to as the "Marks");

2. The goodwill of the on-going and existing business connected with the use of and symbolized by the Marks, as part of the transfer of all on-going and existing business to which the Marks pertain, and including all associated artwork, labels and package designs and other assets that uniquely reflect the Marks; and


3. All rights to damages or profits, due or to become due, accrued or to accrue, arising out of past, present or future infringement of said Marks or injury to said goodwill, together with the right to sue or recover the same in Assignee's name.
