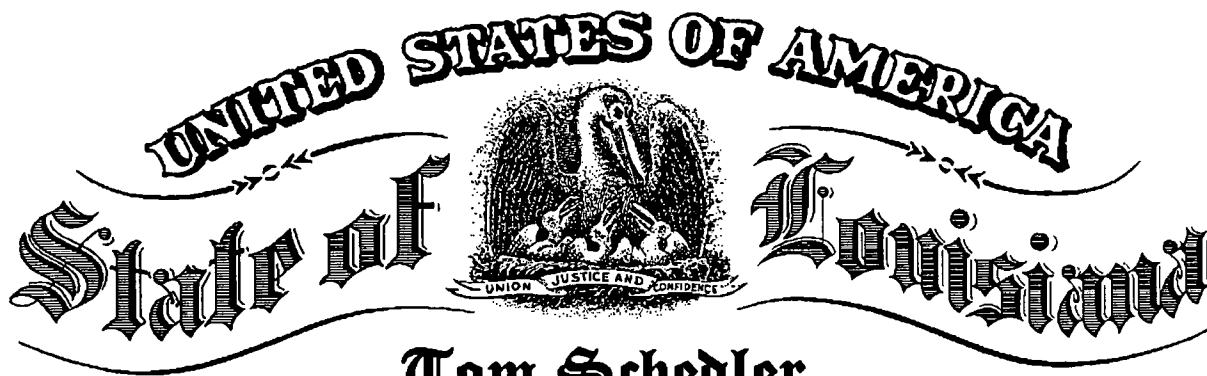

**ARTICLES OF AMENDMENT  
to the  
AMENDED AND RESTATED ARTICLES OF INCORPORATION  
of  
CENTURYTEL, INC.**

The undersigned Corporation (the "Corporation"), acting through Stacey W. Goff, its Executive Vice President, General Counsel and Secretary, and by authority of its Board of Directors, does hereby certify as of May 20, 2010 that:

**FIRST:** On May 20, 2010, the shareholders of the Corporation, at a duly-convened annual shareholders' meeting at which there were present or duly represented holders of 253,619,456 of the 299,766,053 shares of common stock, \$1.00 par value per share, of the Company (the "Common Stock") outstanding on the record date for such meeting (the "Record Date"), and holders of none of the 9,434 shares of Series L preferred stock, \$25.00 par value per share, of the Company (the "Preferred Stock") outstanding on the Record Date, all of whom had one vote per share and voted together as a single class, the holders of 99.17% of the voting power of the Company present or represented at the meeting, by a vote of 251,514,648 shares for, 1,374,743 shares against and 730,065 shares abstaining, adopted resolutions to amend the Corporation's Articles of Incorporation as set forth in paragraph **SECOND** below.


**SECOND:** Article I of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

"The name of the Corporation is CenturyLink, Inc."

**THIRD:** Except as amended by these Articles of Amendment, the Articles of Incorporation of the Corporation shall remain in full force and effect.
