RELEASE OF SECURITY INTEREST TRADEMARK COLLATERAL ASSIGNMENT (SECOND LIEN)

This RELEASE OF SECURITY INTEREST, dated September 28, 2012 ("Agreement"), is made and entered into among JEFFERIES FINANCE LLC as Administrative Agent for the Secured Parties (in such capacity, "Second Lien Administrative Agent") and STATION GVR ACQUISITION, LLC, a Nevada limited liability company ("GVR").

WHEREAS, the Second Lien Administrative Agent, GVR, GVR Holdco 1 LLC ("<u>Holdings</u>"), and the lenders party thereto from time to time have entered that certain Second Lien Credit Agreement, dated June 16, 2011 (as amended, restated, supplemented and/or otherwise modified from time to time, the "Second Lien Credit Agreement");

WHEREAS, GVR, Holdings and the Second Lien Administrative Agent have entered into a Second Lien Security Agreement dated June 16, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, to secure its obligations under the Second Lien Credit Agreement and the Security Agreement, GVR entered into that certain Confirmatory Grant of Security Interest (Second Lien) in United States Trademarks, dated June 16, 2011 (the "<u>Trademark Collateral Assignment</u>"), wherein it assigned certain collateral to the Second Lien Administrative Agent, including the Trademarks (as defined in the Trademark Collateral Assignment) listed in **Schedule A** attached hereto (collectively, the "<u>GVR Marks</u>"); and

WHEREAS, all obligations under the Second Lien Credit Agreement have been satisfied and all liens under the Security Agreement and the Trademark Collateral Agreement have been terminated, and the Second Lien Administrative Agent wishes to terminate and release all security interests, pledges, assignments, mortgages and liens of record granted to it in the GVR Marks under the Trademark Collateral Assignment and the Security Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, receipt of which is hereby acknowledged, the Second Lien Administrative Agent and GVR agree as follows:

- 1. Release. The Second Lien Administrative Agent hereby discharges, terminates and releases all security interests, pledges, assignments, mortgages and liens granted to it (collectively, "Security Interests") in the GVR Marks under the Trademark Collateral Assignment, and agrees that all of the Security Interests in the GVR Marks are hereby discharged, terminated and released and hereby transfers and assigns to GVR any and all right, title and interest that the Second Lien Administrative Agent may have obtained in, to and under the GVR Marks under the Trademark Collateral Assignment and the Security Agreement.
- 2. <u>Perfection</u>. Each of GVR and the Second Lien Administrative Agent hereby authorizes the Director of the United States Patent and Trademark Office to record this Agreement to reflect the release of Security Interests and reassignment of any interests with respect to the GVR Marks.
