RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of September 19, 2012 ("Effective Date") in favor of 3D Research Corporation ("3DRC") by Citizens Bank of Pennsylvania, as Administrative Agent (the "Administrative Agent").

WHEREAS, Schafer Corporation ("Schafer"), and RBS Citizens, N.A., successor by merger with Citizens Bank of Massachusetts (the "Original Lender") entered into that certain Loan and Security Agreement by and between Schafer, Original Lender and the other parties thereto dated December 13, 2005 (the "Original Loan Agreement");

WHEREAS, pursuant to the Original Loan Agreement, 3DRC, who was at that time a wholly-owned subsidiary of Schafer, granted to the Original Lender a lien on and security interest in all of its right, title and interest in, to and under certain intellectual property and entered into that certain Patent and Trademark Security Agreement dated December 16, 2005 (the "Patent and Trademark Agreement") for the purpose of recording such security interest with respect to the patents and trademarks of 3DRC with the United States Patent and Trademark Office, including those items set forth on Schedules A and B attached thereto;

WHEREAS, the Patent and Trademark Agreement was recorded with the United States Patent and Trademark Office on December 21, 2005 at Reel 3215 and Frames 129-152;

WHEREAS, 3DRC and the Original Lender entered into that certain Reaffirmation and Amendment Agreement dated December 19, 2008 (the "Reaffirmation Agreement"), whereby Schedules A and B of the Patent and Trademark Agreement were amended to include those items set forth on Schedule 1 attached hereto (as further defined in the Reaffirmation Agreement, the "Patent and Trademark Collateral");

WHEREAS, the Reaffirmation Agreement was recorded with the United States Patent and Trademark Office on January 5, 2009 at Reel 3913 and Frames 116-123;

WHEREAS, the Original Lender and the Administrative Agent entered into that certain Assignment of Security Interests in Patents and Trademarks dated June 16, 2011 (the "Assignment") whereby Original Lender assigned, transferred and granted to the Administrative Agent any and all security interests or liens it had against the Patent and Trademark Collateral;

WHEREAS, the Assignment was recorded with the United States Patent and Trademark Office on July 11, 2011 at Reel 4579, and Frames 675-680;

WHEREAS, in connection with the Assignment, 3DRC and its then-affiliate Asynchrony Solutions, Inc. (collectively, the "Granting Parties") and the Administrative Agent entered into that certain Grant of Security Interest in Trademarks Agreement dated June 16, 2011 (the "Trademark Security Agreement") whereby the Granting Parties granted a continuing security interest in all of their right, title and interest in the Patent and Trademark Collateral,

including to the trademarks owned by 3DRC set forth on Schedule 1 hereto (the “3DRC Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 11, 2011 at Reel 4579, and Frames 689-695; and

WHEREAS, 3DRC is no longer a subsidiary of Schafer and its assets are no longer subject to the security interests and liens created by the aforementioned agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates, cancels and releases any and all security interests it has against the 3DRC Trademark Collateral, and (ii) re-assigns any right, title and interest it may have in, to and under the 3DRC Trademark Collateral to 3DRC.


The Administrative Agent shall, at 3DRC’s expense, take all further actions, and provide to 3DRC, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by 3DRC to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
