## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of September 28, 2012, is made by Manufacturers and Traders Trust Company (the "Lender") for certain banks and other financial institutions or entities (the "Lenders"), from time to time parties to the Loan Agreement (as hereinafter defined).

### WITNESSETH:

WHEREAS, in connection with that certain Loan and Security Agreement, dated as of March 1, 2006 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"; all capitalized terms contained herein but not otherwise defined shall have their meaning as defined in the Loan Agreement) between Ollie's Bargain Outlet, Inc., a Pennsylvania corporation (the "Borrower") and the Lender, the Borrower granted certain liens on and security interests in (the "Security Interests") certain collateral, including the Trademarks listed on Schedule A hereto, in favor of the Lender, for the benefit of the Lender; and for the purpose of recording such Security Interests with respect to the Trademarks with the United States Patent and Trademark Office, the Borrower entered into a Security Agreement dated March 1, 2006 in favor of the Lender for its trademarks (the "Security Agreement").

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 6, 2006, at Reel 3259 and Frame 0183 with respect to United States trademarks and trademark applications.

WHEREAS, the loan under the Loan Agreement has been paid in full and in connection therewith, the Lender now desires to terminate and release the entirety of its Security Interests in the Trademarks;

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Release of Security Interests. The Lender hereby terminates, releases and discharges the Security Interests in the Trademarks, and any right, title or interest of the Lender in such Trademarks pursuant to the Security Interests shall hereby cease and become void.
2. Further Assurances. The Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interests contemplated hereby.
3. Recordation. The Lender authorizes and requests that the United States Commissioner for Trademarks and any other applicable government officer record this Termination and Release.
4. Governing Law. This Termination and Release shall be governed by, and construed in accordance with, the laws of the State of New York.
