TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is granted as of September 28, 2012 by U.S. BANK NATIONAL ASSOCIATION, a national banking association, as administrative agent for the Lenders (in such capacity, the "Agent"), in favor of COEUR, INC. ("Coeur"), a corporation organized under the laws of the State of Indiana.

WHEREAS, Coeur is a party with Agent and the Lenders to a Credit Agreement dated as of October 10, 2008 (as amended, supplemented, extended, restated, or otherwise modified prior to the date hereof, the "Credit Agreement") pursuant to which the Agent and the Lenders agreed, among other things, to extend certain credit accommodations to Coeur under the terms and conditions set forth therein;

WHEREAS, pursuant to the Credit Agreement, Coeur executed and delivered a Collateral Assignment Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Collateral Assignment") granting the Agent a security interest in and lien on certain Trademark Collateral (as defined below);

WHEREAS, the Collateral Assignment was dated as of October 10, 2008, and was recorded with the United States Patent and Trademark Office ("PTO") against the Trademark Collateral identified on Exhibit A hereto on October 22, 2008, at Reel 003875, Frame 0276;

WHEREAS, Coeur has satisfied all of the obligations under the Credit Agreement and has requested that the Agent terminate and release its security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms used herein without definition are used as defined in the Credit Agreement.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its security interest in and liens on the Collateral of Coeur that was the subject of the Collateral Assignment (Trademarks) dated October 10, 2008 (collectively, the "Trademark Collateral") which includes, without limitation, the following:


those trademarks and tradenames set forth on Exhibit A, and including, without limitation, any and all applications and registrations for those trademarks, any and all common law rights in trademarks owned by Coeur, all proceeds thereof together with the right to recover for past, present, and future infringements, all rights corresponding thereto throughout the world, and all renewals and extensions thereof, together with the goodwill of the business associated with said trademarks.

3. Reassignment. The Agent hereby reassigns, grants and conveys to Coeur, without any representation, recourse or undertaking by the Agent, all of the Agent's right, title and interest in and to the Trademark Collateral.
