NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY is made the 31st day of August, 2012 by and between THE PRIVATEBANK AND TRUST COMPANY, as administrative agent for itself and all Lenders party to the Credit Agreement (as defined below) (in such capacity, "Agent"), and Dickten Masch Plastics, LLC, a Delaware limited liability company ("Dickten Masch").

Dickten Masch and Agent acknowledge the following:

A. Pursuant to a Loan and Security Agreement dated as of August 31, 2012 (as amended, restated or otherwise modified from time to time, the "Credit Agreement"; capitalized terms not otherwise defined herein have the meaning assigned to such terms in the Credit Agreement) by and among Dickten Masch, DMN Acquisition, Inc., the lenders from time to time party thereto (the "Lenders"), and The PrivateBank and Trust Company, as Administrative Agent for the Lenders, the Lenders have agreed to make loans and provide financial accommodations to Dickten Masch and other Loan Parties on the terms and conditions set forth therein.

B. To secure the Obligations, Dickten Masch has granted to Agent for the benefit of itself, the Lenders and certain Affiliates of Lenders, a security interest in substantially all of its assets pursuant to the terms and conditions of the Credit Agreement and the other Loan Documents.

C. Dickten Masch owns the trademark listed on Exhibit A attached hereto (the "Trademark"), which Trademark has been granted by, or applications therefor are pending before, the United States Patent and Trademark Office.

D. Dickten Masch has granted to Agent for the benefit of itself, the Lenders and certain Affiliates of Lenders, a security interest in the Trademark on the terms and conditions set forth in the Credit Agreement and Loan Documents.

E. This Notice of Security Interest in Intellectual Property does not amend, expand, modify or otherwise alter the rights, responsibilities and obligations of the parties as detailed in the Credit Agreement or the other Loan Documents.




