RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST dated as of September 25, 2012 (the "Release") is made by Credit Suisse, Cayman Islands Branch ("Credit Suisse"), in its capacity as collateral agent (the "Collateral Agent") for the Secured Parties pursuant to that certain First Lien Intellectual Property Security Agreement (the "IP Security Agreement") dated as of August 14, 2007, by and between Alpha Media Group Inc. and Dennis Publishing, Inc. (collectively, "Grantors"), as required pursuant to that certain First Lien Guarantee and Collateral Agreement dated as of August 14, 2007 made by the Grantors to the Collateral Agent (the "Guarantee and Collateral Agreement").

WHEREAS, under the terms of the Guarantee and Collateral Agreement, the Grantors granted to the Collateral Agent a security interest in certain intellectual property of the Grantors, including those trademark registrations identified on Exhibit A (U.S.) and Exhibit B (non-U.S.) hereto (collectively, the "Trademarks"), and agreed to execute the IP Security Agreement and to record such IP Security Agreement with the United States Patent and Trademark Office ("PTO");

WHEREAS, the IP Security Agreement was recorded with the PTO at Reel/Frame 3612/0428; and

WHEREAS, Credit Suisse wishes to: (i) release all of its security interest in the Trademarks; (ii) restore all right, title and interest in, to and under the Trademarks to the Grantors; and (iii) dissolve any and all liens and encumbrances in respect of the Trademarks under the Guarantee and Collateral Agreement and the IP Security Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Credit Suisse does hereby release all of its security interest in all of Grantors' right, title and interest in and to:

- (a) the Trademarks, together with the goodwill symbolized thereby;
- (b) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of the Trademarks, all rights in the Trademarks provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantors relating to the Trademarks accruing thereunder or pertaining thereto;
- (c) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to the Trademarks, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- (d) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Trademarks of or arising from any of the foregoing.
