Assignor agrees to cooperate with Assignee and to execute and deliver all papers, instruments and assignments as may be necessary to vest all right, title and interest in and to the Trademarks, including, without limitation, recordation of the assignment in the United States Patent and Trademark Office.

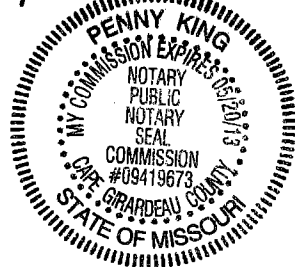

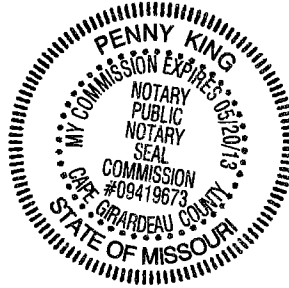
