Assignor hereby authorizes all governmental trademark offices and/or any official of any country empowered to receive trademark applications or issue trademark registrations, to record this assignment, and to issue or transfer all said Trademarks to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Agreement.


This Agreement reflects the entire agreement and understanding between the Parties. There are no warranties or obligations assumed by either Party, except as set out herein.



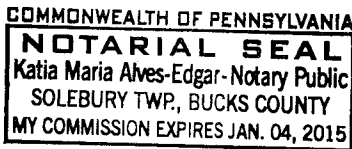
