III.

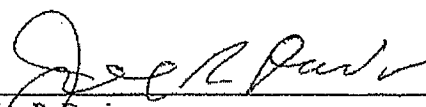
The amendment to the Articles of Incorporation of the Corporation was adopted on January 31, 2007.
