## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is dated as of October 3, 2012 ("Effective Date") by **GE Canada Finance Holding Company**, in its capacity as collateral agent and administrative agent for the lending institutions (the "Lenders") from time to time party to the Credit Agreement (as hereinafter defined), as pledgee, assignee and secured party (in such capacities and together with any successors in such capacities, the "Collateral Agent"), in favor of **Waddington North America, Inc.**, a Massachusetts corporation ("US Borrower"), **WNA Holding Company**, a Delaware corporation ("Holdings"), and each of the other guarantors listed on Schedule A attached hereto, or from time to time party to the Security Agreement (as hereinafter defined) by execution of a joinder agreement (collectively, and together with Holdings and US Borrower, the "Guarantors"), as pledgors, assignors and debtors (in such capacities and together with any successors in such capacities, the "Pledgors," and each, a "Pledgor").

**WHEREAS**, pursuant to the terms and conditions of that certain Security Agreement by and between Pledgors and Collateral Agent dated August 9, 2006 (the "Security Agreement"), each Pledgor granted to Collateral Agent a security interest in and to and pledge of all of the right, title and interest of such Pledgor in, to and under the Intellectual Property Collateral (as defined in the Security Agreement), including, without limitation, the trademark registrations, trademark applications, and unregistered trademarks set forth on Schedule B attached hereto, in each case, together with the goodwill associated therewith (the "Trademarks"), and the patents and patent applications set forth on Schedule C attached hereto (the "Patents");

**WHEREAS**, Pledgors and Collateral Agent entered into the Security Agreement pursuant to the terms and conditions of that certain Credit Agreement dated as of August 9, 2006 among 6599389 Canada Inc., the Guarantors, the Lenders, the Collateral Agent, GE Canada Finance Holding Company, as L/C Issuer, GE Capital Canada, Inc., as L/C Guarantor, and GE Capital Markets, Inc., in its capacities as Sole Bookrunner and Sole Lead Arranger (the "Credit Agreement");

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on August 14, 2006 at Reel/Frame 3368/0838 and Reel/Frame 018099/0462; and

**WHEREAS**, Pledgors have paid all of their outstanding indebtedness to Collateral Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates the Security Agreement and the Credit Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral, including without limitation the Trademarks and the Patents.

Collateral Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise


encumbered any security interest it has against the Intellectual Property Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, trademark registration, trademark application, trade name or assumed name, or any patent or patent application held by any Pledgor, other than the Trademarks and Patents set forth on Schedules B and C (attached hereto), in any jurisdiction throughout the world.

Collateral Agent shall take all further actions, and provide to Pledgors, and each Pledgor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Pledgors to more fully and effectively effectuate the purposes of this Release.
