RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of October 5, 2012 (the "Trademark Security Release"), is made by Bank of America, N.A., in its capacity as administrative agent for the Lenders (as defined in the Credit Agreement defined below) (in such capacity, the "Administrative Agent"), in favor of Retrievox Financing Corp., a Delaware corporation, Retrievox, Inc., a Massachusetts corporation, and Retrievox Acquisition Corp. II (successor by merger to Retrievox Acquisition Corp. V), a Delaware corporation (collectively, the "Grantors").

WHEREAS, the Administrative Agent, the Lenders and Grantors entered into that certain Amended and Restated Credit Agreement, dated as of January 19, 2011 (as in effect from time to time, the "Credit Agreement"), which provides for the credit facilities (the "Loans") upon the terms and subject to the conditions set forth therein;

WHEREAS, Grantor pledged and granted to the Administrative Agent, a continuing security interest in the following property (collectively, the "Trademark Collateral"):

(a)(i) all of their trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, and all goodwill of the businesses associated therewith, now existing or hereafter adopted or acquired including those filed or registered items referred to in Schedule I attached hereto, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any other country or political subdivision thereof or otherwise, and all common-law rights relating to the foregoing, and (ii) the right to obtain all reissues, extensions or renewals of the foregoing (each, a "Trademark");

(b) all Trademark licenses for the grant by or to the Grantors of any right to use any Trademark, including any Trademark license referred to in Schedule I attached hereto; and

(c) all proceeds of, and rights associated with, the foregoing, including any claim by the Grantors against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license.

WHEREAS, the above-referenced security interest was recorded in the United States Patent and Trademark Office (i) on January 21, 2011 on **Reel/Frame 4458/0684** and (ii) on December 16, 2011 on **Reel/Frame 4681/0158**; and

WHEREAS, the Loans secured by the Trademark Collateral have been repaid;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. The Administrative Agent hereby reassigns to Grantors, and releases, terminates and discharges the Administrative Agent's security interest in, to and under the Trademark

Collateral and authorizes and requests the United States Patent and Trademark Office, and any other location where the security interest was filed, to note and record the existence of such release hereby given.


2. This Trademark Security Release shall be governed by, and construed under the internal laws of the State of New York, without reference to principles of conflicts of laws or choice of laws.
