**RELEASE OF SECURITY INTEREST IN  
UNITED STATES TRADEMARK**

The Administrative Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as the Grantor may reasonably request in order to perfect, confirm or evidence such release.
