## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement"), dated as of October 1, 2012, is made by and between Gaylord Entertainment Company, a Delaware corporation (the "Assignor") (which, as of the date hereof, is merging with and into its subsidiary, Ryman Hospitality Properties, Inc., a Delaware corporation), and Marriott International, Inc. a Delaware corporation (the "Assignee").

WHEREAS, the Assignor is the owner of all right, title and interest in and to the trademarks set forth on the attached *Annex A*, including the listed applications and registrations therefor (the "Trademarks"), and the copyright registrations set forth on the attached *Annex B* (the "Copyrights"), (collectively, the "Trademarks and Copyrights");

WHEREAS, the Assignor and the Assignee have entered into a Purchase Agreement, dated as of May 30, 2012 (the "Purchase Agreement"), pursuant to which the Assignor has agreed to assign to the Assignee the Trademarks, along with the goodwill pertaining thereto and associated therewith, as the successor in interest to that portion of Assignor's business associated with the Trademarks;

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to assign to the Assignee the Copyrights, along with the entire copyrights in perpetuity therein and all renewals, reversions and extensions thereof; and

WHEREAS, Assignee desires to acquire all of the Assignor's right, title and interest in and to the Assignor's Trademarks, along with the goodwill pertaining thereto and associated therewith, as the successor in interest to that portion of Assignor's business associated with the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignment of Trademarks. Assignor hereby assigns to Assignee, and Assignee hereby accepts the assignment of, all of Assignor's right, title and interest in and to (i) Assignor's Trademarks and the goodwill pertaining thereto and associated therewith, and (ii) Assignor's Copyrights in perpetuity and all renewals, reversions and extensions thereof, and including without limitation the right to sue for relief and recover damages for past, present or future infringement or dilution of such Trademarks and Copyrights, as applicable.

2. Recordation. Assignor authorizes and requests the Trademark Office of each country listed in Annex A to record the change of ownership of the Assignor's respective Trademarks as having become the property of Assignee in each respective country. Assignor authorizes and requests the United States Copyright Office record the change of ownership of the Assignor's Copyrights listed on Annex B as having become the property of Assignee.

3. Governing Law. This Agreement and all disputes or controversies arising out of or relating to this Agreement or the transactions contemplated hereby shall be governed by, and construed in accordance with, the internal laws of the State of Delaware, without regard to the

laws of any other jurisdiction that might be applied because of the conflicts of laws principles of the State of Delaware.


4. Counterparts. This Agreement may be executed in two or more counterparts, all of which shall be considered one and the same instrument and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other party. This Agreement may be executed by facsimile signature and a facsimile signature shall constitute an original for all purposes.

5. Relationship to Purchase Agreement. Notwithstanding anything to the contrary herein, Assignor is executing and delivering this Agreement in accordance with and subject to all the terms, provisions and limitations set forth in the Purchase Agreement. Nothing in this Agreement shall alter any liability or obligation of the Assignor or the Assignee arising under the Purchase Agreement. If there shall be any conflict between the terms of this Agreement and the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern and control.


