## **TRADEMARK SECURITY AGREEMENT (USPTO)**

This **TRADEMARK SECURITY AGREEMENT (USPTO)** (this "Agreement"), dated as of October 9, 2012, is entered into by and between **SBD HOLDINGS GROUP CORP.**, a Delaware corporation ("Debtor"), and **CITY NATIONAL BANK**, a national banking association ("Secured Party"), with reference to the following:

W I T N E S S E T H:

**WHEREAS**, Debtor and Secured Party have entered into that certain Loan and Security Agreement, of even date herewith (as amended, restated, modified, renewed or extended from time to time, the "Loan Agreement"), pursuant to which Secured Party has agreed to make certain financial accommodations to Debtor and Debtor has granted to Secured Party security interests in (among other things) all of the general intangibles of Debtor;

**WHEREAS**, Secured Party is willing to make financial accommodations to Debtor provided for in the Loan Agreement and the other Loan Documents, but only upon the condition, among others, that Debtor shall have executed and delivered to Secured Party that certain Trademark Security Agreement, dated as of October 9, 2012 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement"); and

**WHEREAS**, pursuant to the Loan Agreement, and as one of the conditions precedent to the obligations of Secured Party under the Loan Agreement, Debtor has agreed to execute and deliver this Agreement to Secured Party for filing with the PTO and with any other relevant recording systems in any domestic jurisdiction, and as further evidence of and to effectuate Secured Party's existing security interests in the trademarks and other general intangibles described herein.

**NOW, THEREFORE**, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Debtor hereby agrees in favor of Secured Party as follows:

1. Defined Terms. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or, if not defined therein, in the Loan Agreement, and this Agreement shall be subject to the rules of construction set forth in Section 1(c) of the Trademark Security Agreement, which rules of construction are incorporated herein by this reference, *mutatis mutandis*.

2. Security Interest.

(a) Grant of Security Interests. To secure the prompt payment and performance of the Secured Obligations, Debtor hereby grants to Secured Party continuing security interest (referred to in this Agreement as the "Security Interest") in all of Debtor's right, title and interest in and to the following property, whether now existing or hereafter acquired or arising and whether registered or unregistered (collectively, the "Trademark Collateral"):

(i) all Trademarks;

(ii) all claims, causes of action and rights to sue for past, present or future infringement or unconsented use of any Trademarks and all rights arising therefrom and pertaining thereto;

(iii) all general intangibles related to or arising out of any of the Trademarks and all the goodwill of Debtor's business symbolized by the Trademarks or associated therewith; and

(iv) all Proceeds of any and all of the foregoing Trademark Collateral (including license royalties, rights to payment, accounts receivable and proceeds of infringement suits) and, to the extent not otherwise included, all payments under insurance (whether or not Secured Party is the loss payee thereof) or any indemnity, warranty or guaranty payable by reason of loss or damage to or otherwise with respect to the foregoing Trademark Collateral.

(b) Continuing Security Interests. Debtor agrees that this Agreement shall create continuing security interests in the Trademark Collateral which shall remain in effect until terminated.

Notwithstanding the foregoing, no grant of any security interest shall be deemed granted hereunder on or in any intent-to-use Trademark application for which a statement of use has not been filed and accepted with the PTO, to the extent granting of a security interest therein would impair the validity or enforceability of, or void, such intent-to-use Trademark application or any registration issuing therefrom under applicable federal law.

3. Security For Secured Obligations. This Agreement and the Security Interest created hereby secures the payment and performance of the Secured Obligations, whether now existing or arising hereafter. Without limiting the generality of the foregoing, this Agreement secures the payment of all amounts which constitute part of the Secured Obligations and would be owed by Debtor to Secured Party, whether or not they are unenforceable or not allowable due to the existence of an Insolvency Proceeding involving Debtor.

4. Security Agreement. The Security Interest granted pursuant to this Agreement is granted in conjunction with the security interests granted to Secured Party pursuant to the Trademark Security Agreement and Loan Agreement. Debtor hereby acknowledges and affirms that the rights and remedies of Secured Party with respect to the Security Interest in the Trademark Collateral made and granted hereby are more fully set forth in the Trademark Security Agreement and the Loan Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. Nothing contained in this Agreement shall limit any of the rights or remedies of Secured Party under the Loan Agreement. To the extent there is any inconsistency between (i) this Agreement and the Trademark Security Agreement, the Trademark Security Agreement shall control and (ii) this Agreement and the Loan Agreement, the Loan Agreement shall control.

5. Authorization To Supplement. If Debtor shall obtain rights to any new Trademarks, the provisions of this Agreement shall automatically apply thereto. Debtor shall give notice in writing to Secured Party with respect to any such new trademarks to the extent required by any of the Loan Documents. Without limiting Debtor's obligations under this

Section, Debtor hereby authorizes Secured Party unilaterally to modify this Agreement by amending Schedule I to include any such new Trademarks of Debtor. Notwithstanding the foregoing, no failure to so modify this Agreement or amend Schedule I shall in any way affect, invalidate or detract from Secured Party's continuing security interest in all Collateral, whether or not listed on Schedule I.


6. Counterparts. This Agreement may be executed in any number of counterparts and by different parties on separate counterparts, each of which, when executed and delivered, shall be deemed to be an original, and all of which, when taken together, shall constitute but one and the same Agreement. Delivery of an executed counterpart of this Agreement by telefacsimile or other electronic method of transmission shall be equally as effective as delivery of an original executed counterpart of this Agreement. Any party delivering an executed counterpart of this Agreement by telefacsimile or other electronic method of transmission also shall deliver an original executed counterpart of this Agreement but the failure to deliver an original executed counterpart shall not affect the validity, enforceability, and binding effect of this Agreement. The foregoing shall apply to each other Loan Document *mutatis mutandis*.

7. CHOICE OF LAW AND VENUE, JURY TRIAL WAIVER. THIS AGREEMENT SHALL BE SUBJECT TO THE PROVISIONS REGARDING CHOICE OF LAW AND VENUE, JURY TRIAL WAIVER, AND JUDICIAL REFERENCE SET FORTH IN SECTION 13 OF THE LOAN AGREEMENT, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, *MUTATIS MUTANDIS*.


