

CERTIFICATE OF OWNERSHIP AND MERGER

(a Delaware corporation)

Pursuant to Section 253 of the General Corporation Law of the State of Delaware

Spike Cable Networks Inc., a Delaware corporation (the "Corporation") HEREBY CERTIFIES AS FOLLOWS:

FIRST: The Corporation is a corporation incorporated on June 19, 1925, under the laws of the State of Delaware.

SECOND: The Corporation owns all of the outstanding shares of common stock of Network Enterprises, Inc., a corporation incorporated on February 24, 1994 under the laws of the State of Tennessee.

THIRD: On June 26, 2012, the Board of Directors of the Corporation duly adopted by unanimous written consent of its members the following resolutions to merge the Subsidiary with and into the Corporation:

RESOLVED, that Network Enterprises, Inc., a Tennessee corporation (the "Subsidiary") be merged with and into the Corporation (the "Merger") pursuant to Section 253 of the General Corporation Law of the State of Delaware (the "DGCL") and Section 48-21-105 of the Business Corporation Act of the State of Tennessee (the "TBCA") and in accordance with the Certificate of Ownership and Merger, a Plan of Merger and the Articles of Merger in the forms attached hereto as Exhibits A, B, and C, respectively, which are hereby approved and adopted; and that each of the officers of the Corporation, acting alone, is hereby authorized to execute and file the Certificate of Ownership and Merger with the Secretary of State of the State of Delaware and the Articles of Merger with the Secretary of State of the State of Tennessee; and

FURTHER RESOLVED, that the Merger shall become effective at the time (the "Effective Time") of the filing of the Certificate of Ownership and Merger with the Secretary of State of the State of Delaware in accordance with the

provisions of the DGCL and the Articles of Merger with the Secretary of State of Tennessee in accordance with Section 49-21-105 of the TBCA; and

FURTHER RESOLVED, that, at the Effective Time, the Subsidiary shall be merged with and into the Corporation, the separate existence of the Subsidiary shall cease, and the Corporation shall be the surviving corporation (the "Surviving Corporation"), and shall possess all of the estate, property, rights, privileges, powers, and franchises of the Corporation and of the Subsidiary, as fully and entirely and without change or diminution as the same were before held and enjoyed by the Corporation and the Subsidiary in each of their names; and

FURTHER RESOLVED, that, at the Effective Time, the Surviving Corporation shall be subject to all of the obligations of the Subsidiary; and

FURTHER RESOLVED, that the Certificate of Incorporation and Bylaws of the Corporation, as in effect immediately prior to the Effective Time, shall be the Certificate of Incorporation and Bylaws of the Surviving Corporation until thereafter amended as provided by law or such Certificate of Incorporation; and

FURTHER RESOLVED, that, at the Effective Time, each share of the Common Stock of the Subsidiary which is issued and outstanding immediately prior to the Effective Time shall be cancelled; and

FURTHER RESOLVED, that, at the Effective Time, each share of the Common Stock, \$0.01 par value per share, of the Corporation which is issued and outstanding immediately prior to the Effective Time shall remain outstanding following the Effective Time;

FURTHER RESOLVED, that the directors and officers of the Corporation as of the Effective Time shall be the directors and officers of the Surviving Corporation until their successors are duly elected or appointed; and

FURTHER RESOLVED, that the Corporation shall cause to be executed and filed and/or recorded the documents prescribed by the laws of the State of Delaware and by the laws of any other appropriate jurisdiction and will cause to be performed all necessary acts within the State of Delaware and within any other appropriate jurisdiction; and

FURTHER RESOLVED, that each of the officers of the Corporation, acting alone, is hereby authorized to prepare, execute, deliver and file all agreements, instruments, documents and certificates in the name and on behalf of the Corporation, to pay all such fees and expenses as the officer or officers may deem necessary or appropriate in order to effect the Merger, and to perform any acts as may be deemed necessary or appropriate by the officer or officers so acting to effectuate the intent of the foregoing resolutions.
