## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Trademark Assignment Agreement”) is made as of September 28, 2012 by and between SH Holdings, LLC, a Florida limited liability company with principal offices at 1990 Main Street, Suite 750, Sarasota, Florida 34236 (“Assignor”) and SH Franchising, LLC, a Florida limited liability company with principal offices at 1990 Main Street, Suite 750, Sarasota, Florida 34236 (“Assignee”).

Assignor is the owner of the trademarks, service marks, and trade names listed on Exhibit A to this Trademark Assignment Agreement (the “Marks”);

Assignor and Assignee are parties to that certain Certificate of Merger dated as of September 28, 2012 (“Certificate of Merger”), pursuant to which Assignor was merged with and into Assignee with Assignee continuing on as the surviving entity following such merger;

In consideration of the transactions contemplated by the Certificate of Merger, Assignor desires to assign to Assignee all of Assignor’s right, title and interest in and to the Marks and Assignee desires to accept such assignment.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby sell, grant, convey and assign unto Assignee, its successors and assigns all right, title and interest in and to the Marks and all goodwill symbolized by and associated with the business conducted under such Marks, which business is ongoing and existing including all rights therein provided by international conventions and treaties, as well as any and all rights derived from the use of the Marks, either by itself or by its franchisees, as well as the right to sue for past, present, and future infringement of the Marks.
2. Assignor shall record the assignment with all registrars of its trademarks. Assignor agrees to execute such other documents as may be requested by Assignee to give effect to the terms of this Trademark Assignment Agreement.
