**CONFIRMATORY ASSIGNMENT FOR RECORDING
IN THE UNITED STATES PATENT AND TRADEMARK OFFICE**

WHEREAS, on 5 March 2012, Pride Mobility Products Corporation, a Pennsylvania corporation having its principal place of business at 182 Susquehanna Avenue, Exeter, Pennsylvania, 18643, as the high bidder in a sealed bid auction purchased "Lot C"¹, namely certain business intangibles and certain intellectual property and ancillary goodwill, with all such rights being subject to a License Agreement dated 19 July 2010 (as amended by agreement dated 28 June 2011) between Electric Mobility Corporation and Electric Mobility Europe, the purchase by Pride Mobility Products Corporation being from Electric Mobility Corporation, a New Jersey corporation having its principal place of business at 591 Mantua Boulevard, Sewell, New Jersey, 08080, with the winning bid by Pride Mobility Products Corporation being Fifty-Six Thousand, One Hundred Dollars (\$56,100.00), paid via check to the auctioneer, William F. Comly & Son, Inc., doing business at 1825 East Boston Street, Philadelphia, Pennsylvania, 19125;

WHEREAS, the parties wish to confirm the sale by Electric Mobility Corporation and the purchase by Pride Mobility Products Corporation of such "Lot C", namely certain business intangibles including certain intellectual property comprising the United States trademark registration set forth in the attached Schedule 1 and the goodwill that is associated with and ancillary to the single individual United States trademark registration set forth in the attached Schedule 1, together with all common law and all other rights of any type in such trademark, with all of such acquired rights being subject to the aforementioned License Agreement dated 19 July 2010 (as amended by agreement dated 28 June 2011) between Electric Mobility Corporation and Electric Mobility Europe, with the sale and purchase being via auction on the date stated above;

WHEREAS, the parties, intending to be legally bound, by their duly authorized representatives, have executed this Confirmatory Assignment evidencing the acquisition by Pride Mobility Products Corporation, subject to the aforementioned License Agreement dated 19 July 2010 (as amended by agreement dated 28 June 2011) between Electric Mobility Corporation and Electric Mobility Europe, of the entire right, title and interest from Electric Mobility Corporation in and to the United States trademark registration listed on Schedule 1 and the goodwill of

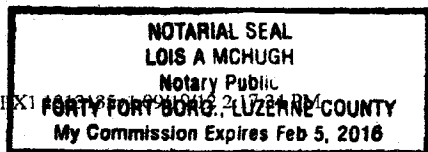
