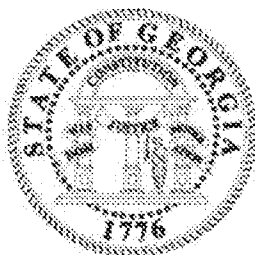

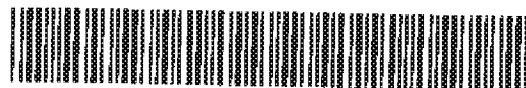
FOURTH: The Plan of Merger was submitted to, and duly approved by, the sole member of IS LLC and the sole shareholder of Presidio.
