NOW, THEREFORE, for good and valuable consideration, receipt of which is acknowledged, effective as of the first date written above, ASSIGNOR does hereby assign and transfer unto ASSIGNEE, as Agent, all its and their right, title and interest in and to the SKINVINCIBLE Trademark for all goods and services, including but not limited to "Day spa

services, namely, cosmetic and body care services," together with U.S. Registration No. 3,599,181 therefor, and the related goodwill of the business symbolized by and associated with said SKINVINCIBLE Trademark, if any.
