TRADEMARK AND INTELLECTUAL PROPERTY ASSIGNMENT

2. Assignment. Assignor confirms that it has assigned and hereby, irrevocably assigns, free and clear of all liens and encumbrances to Assignee: (a) all of Assignor's right, title, and interest in and to the Trademarks, including, but not limited to, all common law rights and the U.S. federal registrations with respect to the Trademarks, and all goodwill associated with the Trademarks, and (b) the Domain Name, and all rights relating to the Domain Name and the operation of all associated websites, and (c) as to all of the foregoing, the right to sue for past infringements.

3. Further Acts. Assignor shall perform any and all other and further acts and execute and deliver any and all documents that may be necessary for Assignee to perfect and record its ownership interests in the Trademarks and the Domain Name.

4. Miscellaneous. This Assignment (a) is executed and delivered by Assignee based upon Assignor's representations and warranties that he is the sole and exclusive owner of record of the Trademarks and the Domain Name, and that he has the right to transfer and assign them to Assignee, as provided herein, and that he has not assigned or pledged all or any part of such rights to anyone else; (b) shall be binding on the successors, assigns, and licensees of the parties; (c) contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof; and (d) shall be construed in accordance with the laws of the State of California, and as applicable, U.S. federal law.
