## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into this 24 day of September, 2012, by and between Refrigerated Boxes, Inc. a Pennsylvania corporation with a principal address of 11401 Roosevelt Boulevard, Philadelphia, Pennsylvania 19154 ("Assignor"), and Bally Refrigerated Boxes, Inc., a Pennsylvania corporation with a principal address of 135 Little Nine Drive, Morehead City, North Carolina 28557 ("Assignee").

### WITNESSETH:

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title, and interest in and to the U.S. trademark application for BALLY, Registration No. 857032, registered September 17, 1968, (the "Trademark"), together with the goodwill of the business symbolized thereby.

WHEREAS, Assignee desires to acquire all right, title, and interest in and to the Trademark, including all goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, transfers, conveys, and assigns to Assignee all of Assignor's legal and beneficial right, title, and interest in and to the Trademark, together with the goodwill of the business associated with the Trademark.

The rights transferred by this Assignment include the right to bring all legal actions related to the Trademark, including actions for any infringement, whether the infringement occurred before or after this Assignment, and the right to recover damages therefor.

This Assignment shall be governed by the internal laws of the Commonwealth of Pennsylvania without regard to principles of conflicts of law.
