ARTICLES OF MERGER

Pursuant to North Carolina General Statute Section 55-11-05(a), the undersigned hereby submits these Articles of Merger as the surviving business entity in a merger between two or more business entities.

1. The name of the surviving business entity is SchoolDude.com, Inc., a North Carolina corporation (“**SchoolDude**”).

2. The address of SchoolDude is 11000 Regency Parkway, Suite 200, Cary, North Carolina 27518.

3. The name of the merged entity is FacilityDude.com, Inc., a North Carolina corporation.

4. A plan of merger has been duly approved by the Board of Directors of SchoolDude in the manner required by law. Shareholder approval of the plan of merger was not required because SchoolDude was the owner of at least 90% of the outstanding shares of each class of the merging corporation and the plan of merger does not provide for any changes in the articles of incorporation of SchoolDude that requires shareholder action.


