RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this “Release”) is made as of October 12, 2012, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity as the “Administrative Agent”), the secured party under the Security Agreement referred to below.

W I T N E S S E T H:

WHEREAS, WaveDivision Holdings, LLC, a Delaware limited liability company (“WaveDivision”), the other parties thereto and the Administrative Agent executed that certain Security Agreement, dated as of January 4, 2007 (the “Security Agreement”), pursuant to which WaveDivision granted a security interest to the Administrative Agent in certain trademarks and other intellectual property of WaveDivision; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 3455, Frame 0932 on January 5, 2007; and

WHEREAS, the Administrative Agent has agreed to release all its liens on the trademarks and trademark applications of WaveDivision identified on Exhibit A attached hereto and made a part hereof (the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby releases, terminates and discharges all liens and all its rights in and to the Released Collateral, hereby waives and relinquishes all its rights, title, interest, powers, privileges and remedies with respect to the Released Collateral and hereby assigns, transfers and conveys the same to WaveDivision and its successors and assigns, all without warranty or representation of any kind.
