**NOTICE OF RELEASE OF  
SECURITY INTEREST IN UNITED STATES TRADEMARKS  
(Lee Enterprises, Incorporated)**

WHEREAS, by a Grant of Security Interest in United States Trademarks dated January 30, 2012 (the "**Trademark Security Agreement**") and recorded in the United States Patent and Trademark Office at Reel 4730 Frame 0749 on March 5, 2012, Lee Enterprises, Incorporated, a Delaware corporation ("**Assignor**") granted to Deutsche Bank Trust Company Americas, as Collateral Agent ("**Assignee**"), a continuing security interest in (i) all right, title and interest of Assignor in and to the Marks, including but not limited to the United States Trademark listed on Exhibit A (such scheduled Mark, the "**Released Mark**"), (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition or other violation regarding the same. Capitalized terms used herein without definition are used as defined in the Security Agreement among Assignor, the other assignors from time to time party thereto and the Assignee, dated as of January 30, 2012 (as amended, modified, restated and/or supplemented from time to time).

WHEREAS, Assignee wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Mark.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, without recourse and without representation or warranty, Assignee hereby relinquishes, releases and discharges all of its security interest in the Released Mark, whether granted pursuant to the Trademark Security Agreement or any other agreement or document delivered in connection with or related to that Trademark Security Agreement, or arising under applicable law.

The Assignee agrees, at the Assignor's expense, to cooperate with the Assignor, to execute, deliver and file any additional documents, and to provide the Assignor with the information and additional authorization reasonably required or desirable to effect the release, relinquishment or discharge of the Assignee's security interest in the released collateral described herein.
