## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Trademark Assignment") by and between C.H. Robinson Company, a Delaware corporation ("Assignor"), and C.H. Robinson Worldwide, Inc., a Delaware corporation ("Assignee"), is made and entered into effective as of October 11, 2012. Assignor and Assignee are sometimes referred to herein as a "Party" and collectively as the "Parties."

### BACKGROUND

- A. Assignor desires to assign to Assignee, and Assignee desires to receive, the trademarks and domain name registrations set forth on Schedule A attached hereto (the "Trademarks").

### AGREEMENT

Assignor hereby irrevocably assigns, transfers, conveys and delivers to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in and to the Trademarks, together with all goodwill associated therewith and all trademark and domain name registrations, applications and renewals in connection therewith, and all claims for damages by reason of past, present or future infringement, dilution or misappropriation of the foregoing, with the right to sue for and collect the same, and any and all income, royalties and payments now or hereafter due or payable with respect to the Trademarks, for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors, assigns, or other legal representatives.
2. Counterparts. This Trademark Assignment may be executed in counterparts, which together will constitute one and the same agreement.

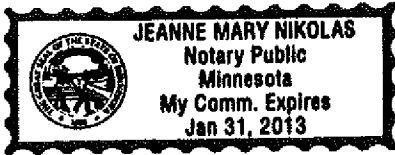

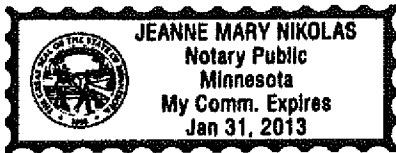
