Trademark Assignment

This Trademark Assignment (the "Assignment") is made by Verve Living Systems, Inc. a Delaware corporation ("Assignor"), the successor in interest to Cottonwood Spark Acquisition, Inc. ("Cottonwood"), in favor of Zeno Controls LLC, a New York limited liability company ("Assignee").

WHEREAS, on March 30, 2012, Liberty Hardware Mfg. Corp., a Florida corporation ("Liberty") executed an assignment of all rights, title and interest in and to the trademarks, associated goodwill, and all corresponding trademark applications and registrations as set forth in that Exhibit A hereto (the "Marks") to Cottonwood;

WHEREAS, Assignor, successor in interest to Cottonwood, has sold certain of its assets as identified in the Asset and Inventory Purchase Agreement dated September 28, 2012 (the "Purchase Agreement") by and among Assignor and Assignee and EnOcean GmbH; and

WHEREAS, pursuant to the Purchase Agreement, Assignor agreed to transfer and did transfer the Marks, as-is without any warranty as to the status or validity thereof, to the Assignee and Assignee agreed to and did acquire the Marks.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee, its successors and assigns, absolutely and forever, its entire right, title, and interest, whether statutory or at common law, in and to the Marks, together with the goodwill of the business symbolized by the Marks and all registrations and applications therefor, together with all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.
