ASSET PURCHASE AND ASSIGNMENT AGREEMENT

This ASSET PURCHASE AND ASSIGNMENT AGREEMENT, dated as of July 1, 2011 (this "Agreement"), is by and between ARKEMA FRANCE, a *société anonyme* organized under the laws of France, as buyer and assignee ("Buyer"), and SARTOMER TECHNOLOGY USA, LLC, a Delaware limited liability company ("Sartomer Technology"), and SARTOMER USA, LLC, a Delaware limited liability company ("Sartomer"), as sellers and assignors (collectively, Sartomer and Sartomer Technology are sometimes referred to herein as the "Sellers").

- 2) Sartomer and Sartomer Technology Sellers own the patents and trademarks attributed to them in the attached Schedule 6.11(a)(i) Sold Companies Intellectual Property – Patents, and Schedule 6.11(a)(i) Sold Companies Intellectual Property – Trademarks, as well as any and all IP rights related thereto (the "Sartomer IP" and the "Sartomer Technology IP", respectively).
- 3) Sartomer, with respect to the Sartomer IP, and Sartomer Technology, with respect to the Sartomer Technology IP, each hereby does sell, assign and transfer unto



Buyer the entire right, title and interest in and to such IP; the same to be held and enjoyed by Buyer for its own use and behalf, and for its legal representatives and assigns, including without limitation:


- a) all pending applications for registration, if any;
- b) the goodwill represented by such IP;
- c) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, and to any causes in action, claims for damages, profits and costs, both in equity and in law, relating to said IP and any patents issued in respect thereof;
- d) the right to sue, counterclaim, and recover for past, present, and future infringement of the rights assigned or to be assigned under this Agreement; and
- e) all rights corresponding thereto;




