**RELEASE OF FIRST LIEN SECURITY INTEREST IN PATENTS AND TRADEMARKS**

This RELEASE OF FIRST LIEN SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Release"), dated as of October 15, 2012, is made by Citibank, N.A., a national banking association with offices at 388 Greenwich Street, 14<sup>th</sup> Floor, New York, New York 10013, as the collateral agent for the Secured Parties defined in the Patent and Trademark Security Agreement (as defined below) ("Assignor"), in favor of Jackson Hewitt Inc., a Virginia corporation with offices at 3 Sylvan Way, Box 264, Parsippany, New Jersey 07054, and Tax Services of America, Inc., a Delaware corporation with offices at 3 Sylvan Way, Box 264, Parsippany, New Jersey 07054 (each an "Assignee" and collectively, "Assignees"). Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Patent and Trademark Security Agreement.

WHEREAS, Assignees and Assignor are parties to that certain (i) Pledge and Security Agreement, dated as of August 16, 2011 (as amended, modified, restated or supplemented from time to time, the "Security Agreement") and (ii) Grant of First Lien Security Interest in Patents and Trademarks, dated as of August 16, 2011 (the "Patent and Trademark Security Agreement");

WHEREAS, pursuant to the Security Agreement and the Patent and Trademark Security Agreement, as security for the payment and performance of the Secured Obligations, Assignees granted, pledged, assigned and delivered to Assignor, for the ratable benefit of the Secured Parties, a Lien upon and security interest in all of its right, title and interest in and to the Trademarks and the Patents, and the use thereof, together with any and all proceeds thereof and the goodwill of the businesses associated therewith or symbolized by the Trademarks. Notwithstanding the foregoing, in no event did the Lien and security interest granted therein attach to any applications for Trademarks filed in the United States Patent and Trademark Office (the "PTO") pursuant to 15 U.S.C. § 1051 Section 1(b) unless and until evidence of use of the mark in interstate commerce is submitted to the PTO pursuant to 15 U.S.C. § 1051 Section 1(c) or Section 1(d);

WHEREAS, the Patent and Trademark Security Agreement was filed with the Commissioner of Patents and was recorded with the Commissioner of Trademarks on September 7, 2011 at Reel/Frame No. 4618/0571; and

WHEREAS, Assignees desire Assignor to terminate and release its Lien upon and security interest in all of Assignees' right, title and interest in and to the Trademarks and the Patents, and the use thereof, together with any and all proceeds thereof and the goodwill of the businesses associated therewith or symbolized by the Trademarks, including the Patents and Trademarks set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby terminates, releases and discharges fully its Lien upon and security interest in all of Assignees' right, title and interest in and to the Trademarks and the Patents, and the use thereof, together with any and all proceeds thereof and the goodwill of the businesses associated therewith or symbolized by the Trademarks, including

the Patents and Trademarks set forth on Schedule A hereto, and hereby reassigns and transfers to Assignees any right, title and interest that Assignor may have in the Patents and Trademarks.

**Assignor hereby authorizes Assignees, or the Assignees' authorized representative, to record this release with the United States Patent and Trademark Office.**

The provisions of Section 8.8 of the Security Agreement regarding governing law, submission to jurisdiction, waiver of venue and service of process and Section 8.9 of the Security Agreement regarding waiver of jury trial are incorporated herein by reference as though specifically set forth herein, *mutatis mutandi*.
