1. FL Industries Holdings, Inc. was incorporated in Delaware on May 31, 1985.
2. On June 11, 1992, FL Industries, Inc. changed its name to Thomas & Betts Holdings, Inc.
3. Thomas & Betts Holdings, Inc. merged into Thomas & Betts Corporation, pursuant to a certificate of merger with an effective date of January 1, 1995.
4. Pursuant to the terms and conditions of the merger, the separate existence of Thomas & Betts Holdings, Inc. ceased, all of its issued and outstanding stock was cancelled, and Thomas & Betts Corporation succeeded to all of the properties, rights and other assets of Thomas & Betts Holdings, Inc.
