ASSIGNMENT OF TRADE-MARKS

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledge, the Assignor does hereby sell, assign, transfer and grant to the Assignee the entire worldwide right, title and interest of the Assignor in and to the Trade-marks, together with all rights and benefits in relation to such Trade-marks that may at any time exist, at present or in the future, the goodwill attaching to the Trade-marks, the right to recover for past infringement of the Trade-marks and the full and irrevocable power to enforce rights in relation to the Trade-marks;

AND, THE ASSIGNOR hereby agrees to do such other things and to execute and sign all documents as may from time to time be required to vest in the Assignee the Trade-marks and to effect a recordation of the assignment of the Trade-marks at or before the proper offices or agencies.

This Assignment shall not be merged in any subsequent assignment or be taken to be a substitute for any former assignment.

This Assignment shall be binding upon and enure to the benefit of the Assignor and Assignee and their respective heirs, executors, administrators and assigns.


This Assignment shall be governed by and construed in accordance with the laws of the Province of Ontario, and the laws of Canada applicable therein.
