RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is entered into by and between SENSAGE, INC. ("SenSage") and MMV FINANCE INC. ("MMV") as of October 12, 2012 (the "Effective Date").

WHEREAS, SenSage granted MMV, a security interest, lien, and charge as set forth in the Confirmation of Grant of Security Interest dated September 2, 2010 and any other security agreement between SenSage and MMV (the "Security Interest") in all of SenSage's rights, title, and interest in and to all of the patents and trademarks set forth on Schedule A attached hereto;

WHEREAS, the patent security interest was recorded in the Assignment Branch of the United States Patent and Trademark Office (the "USPTO") on September 2, 2010 at Reel/Frame 024933/0289, and the trademark security interest was recorded in the Trademark Branch of the USPTO on September 2, 2010 at Reel/Frame 004271/0335; and

WHEREAS, with SenSage having fully satisfied its obligations secured by the Security Interest, MMV agrees to release its Security Interest and agrees to record such release with the USPTO;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. MMV hereby releases, relinquishes, discharges, terminates, and assigns to SenSage the Security Interest and MMV's entire rights, title, and interest in and to the patents and trademarks set forth on Schedule A attached hereto and any other intellectual property of SenSage in which the Security Interest was created. The Security Interest, and any right, title, and interest of MMV in and to such patents, trademarks, and other intellectual property shall hereupon cease and terminate.

2. MMV hereby agrees to execute and deliver all such releases and documents and to take such actions as may be reasonably required to release, relinquish, discharge, terminate, and assign to SenSage the Security Interest.

3. MMV hereby authorizes and requests the Commissioner for Patents and Trademarks and any other applicable government officer to record this Release.



ANNEX 1

POWER OF ATTORNEY

Limited Power of Attorney

This Limited Power of Attorney is being delivered by MMV Capital Partners Inc., assignee of MMV Finance Inc. ("MMV"), to SenSage, Inc. ("SenSage") and Fortis Advisors LLC ("Fortis") in connection with a Payout Letter dated as of the 12th day of October, 2012 (the "Payout Letter").

Capitalized terms not otherwise defined herein shall have the meanings ascribed thereto in the Credit Agreement (as defined in the Payout Letter).

SenSage, Fortis and each of their respective counsel shall be entitled, at their own expense, from time to time to do, execute, acknowledge and deliver all discharges or termination statements reasonably necessary or proper for the discharge of any and all security interest(s) in favour of MMV pursuant to the Credit Agreement or the Security, and for such purposes, MMV does hereby irrevocably appoint SenSage, Fortis and each of their respective counsel the true and lawful attorney-in-fact of MMV with full power of substitution, for it and in its name to execute any discharge statements or termination statements in any applicable jurisdiction. The power and authority hereby given and granted shall be deemed coupled with an interest and not revocable by any party.

Fortis shall deliver to MMV, at no cost to MMV, copies of all such discharge statements or termination statements, together with evidence of filing, including without limitation, all UCC-3 termination statements, within five (5) Business Days of the delivery or filing of same.
